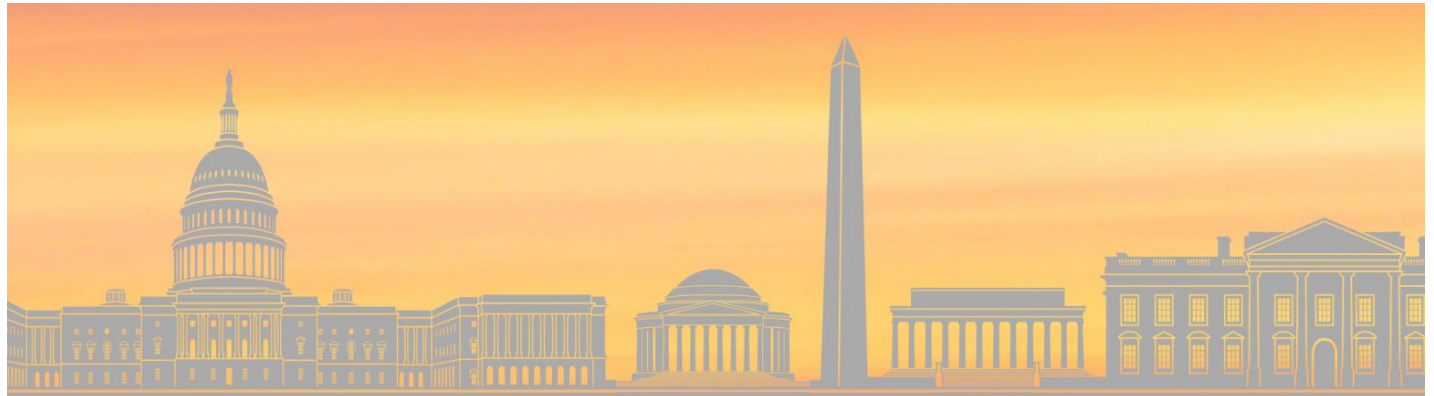
Charlie, a Washington DC native, is Chairman and Founder of Payroll Network. Having graduated in 1963 from Georgetown University as an Accounting Major in the School of Business, Charlie joined the accounting firm of Councilor, Buchanan and Mitchell. He would then use his financial and accounting acumen to establish successful payroll and human resources companies beginning with Hughes Computer Systems, which proved so successful that it was bought by Payroll giant, ADP. In the 1980's, Charlie started Wolf Computers, which went on to become the present day company, Payroll Network.

As his business ventures grew, so too did Charlie's involvement with numerous local civic, religious and educational institutions. His hope for each was to build the financial and governance structures needed to achieve sustained success.

At Georgetown University, Charlie served on the Board of Regents and the Endowment Committee. He was founder of Hoyas Unlimited and President of the University's Washington, D.C. Alumni Chapter. For the Sovereign Military Order of Malta, he served on the Audit and Finance committees. Additionally, he has served on the Boards of the following organizations: So Others Might Eat; Montgomery County Hospice; Loyola Retreat House; Greater Washington Society of CPAs; The Kemper Open Golf Tournament; The Friendly Sons of St. Patrick and the Catholic Business Network of Montgomery County.

Charlie's been called a connector, a networker, an organizer and a bridge builder. A Gonzaga classmate says of Charlie "he is our glue."

The truth is, that long before anyone had even imagined the likes of Linked In, Facebook, Twitter or even Email, Charlie Wolf recognized the inherent value in bringing people together, so they could share their good news, help organizations build structures for success, and raise funds for numerous worthy causes.

### **Father Fred Close**

*Pastor of St. Anthony of Padua*

Fr. Fred Close (Pastor) is a D.C. native who started his education at Brightwood Kindergarten and Nativity Catholic School in NW. In Summit, N.J., he continued his education at St. Theresa of Avila grade school; graduated from St. Benedict's Prep in Newark, N.J.; and matriculated to Boston College (B.A. Economics, 1969) and Boston College Law School (J.D., 1973). After serving for about 25 years in the Criminal Division of the U.S. Department of Justice as a trial attorney, he entered seminary for the Archdiocese of

Washington at Saint John XXIII National Seminary in Weston, MA, and was ordained to the priesthood of Jesus Christ on June 9, 2001.

Father Close served at St. Mary's of Piscataway and St. Patrick's of Norbeck. In 2006, he was assigned to St. Anthony of Padua, where he now serves as Pastor.

This self-described "recovering lawyer" became a priest as a result of encountering Jesus Christ in the Charismatic Renewal Movement, and discerning his vocation at Mother of God Community in Gaithersburg, MD.

At St. Anthony Catholic School, Father Close built on the foundation already here: celebrating weekly Mass for the school; introducing the National Evangelization Retreats; restarting the Blue & Gold newsletter; and starting the Catechesis of the Good Shepherd for the parish and school. When not rebuilding the campus physically, he fought for the selection of a certain principal, who by God's grace makes us all look good!
