### Joseph E. Borger, CPM

Joseph Borger is President of Borger Management, Inc. The original firm, George I. Borger, Inc., was founded in 1930 and has been in continuous operation since that time. Mr. Borger is a graduate of St John's College High School as are more than 20 family members and relatives, including his two sons, Matthew and Michael. Mr. Borger served as a member of the Board of Trustees for both St. John's College High School from 2003- 2014 and the San Miguel School. Mr. Borger was very active at St Jane de Chantal Parish where both of his sons attended. He coached baseball and basketball; served as the President of the CYO and was a member of the parish finance committee.

Mr. Borger has served in many elected positions and has received recognition for his service, including Manager of the Year from the Institute of Real Estate Management and as President of the Greater Metropolitan Washington Chapter. In 1993, he served as President of the D.C. Association of Realtors and was selected as the Realtor of the Year in 1996. Mr. Borger has been active in legislative and political issues related to housing and real estate matters, serving on various committees such as the Mayor's Advisory Commission of Fire Safety and Fire Protection. He is currently the Management Representative Member of the Real Estate Homeland Security Task Force (HSTF). He is a licensed real estate broker in the District of Columbia, Maryland, and Virginia.

In July 2011, Msgr. John Enzler began as the President and CEO of Catholic Charities of the Archdiocese of Washington, charged with leading an agency that serves tens of thousands of people facing the most pressing human needs in our community each year. A native Washingtonian, Father John has more than 40 years of experience as a priest, leader and advocate serving the needs of the most vulnerable in our community. He has been active among several local interfaith networks and is a recognized and respected figure in the metropolitan area community. He was ordained a priest for the Archdiocese of Washington in 1973 and was named Monsignor by Pope John Paul II in 1985. He has served as pastor at three parishes, including most recently at the Shrine of the Most Blessed Sacrament in Washington, DC and continues to serve in his role as Vicar of Development for the Archdiocese of Washington.
